# ASSDA FABRICATOR PROJECT OF THE YEAR 2024

## RULES OF ENTRY

1. **Confidentiality:** All project entries are treated in the strictest confidence.
2. **Eligibility:** Entries are welcome from Members of ASSDA in good standing, i.e., you must be a financial Member of the Association to qualify.
3. **Submission deadline:** All entries must be submitted and received by ASSDA no later than **Friday 20 September 2024**. Submissions should be emailed to [awards@assda.asn.au](mailto:awards@assda.asn.au). Entrants will receive an email acknowledgement of their submission.
4. **Entry requirements:** Each entry must be accompanied by a fully completed submission form illustrated with high-resolution photos. Additional materials such as project media releases, time-lapse videos, etc., may be included to enhance the project submission.
5. **Single design or project:** Each submission is limited to a single design or project and must be done with prior approval from all principal parties involved.
6. **Joint applications:** In the case of a collaborative or joint effort, ASSDA Members may submit a project as a joint application with another eligible ASSDA Member (who complies with point number 2).
7. **Multiple submissions:** ASSDA Members are welcome to submit more than one project submission for consideration across multiple categories. However, you cannot re-submit projects that have previously won, been nominated, or been considered for an ASSDA Award.
8. **Permission for publicity:** By entering the awards, participants grant ASSDA permission to use the entries for publicity purposes, which may include but is not limited to, promotion of the project entries, media releases, social media posts, and website features.
9. **Impartial judging:** Award winners will be determined by a committee of the ASSDA Executive and its consultants. Projects are judged based on the criteria provided:
  - a. **Excellence:** Exceptional work, concepts, and execution
  - b. **Innovation:** Creativity, originality, and advancement
  - c. **Quality:** Productivity and customer service delivered
  - d. **Sustainability and Environmental Considerations:** Minimising your carbon footprint.

The judges' decision is final, and no correspondence will be entered into.
